

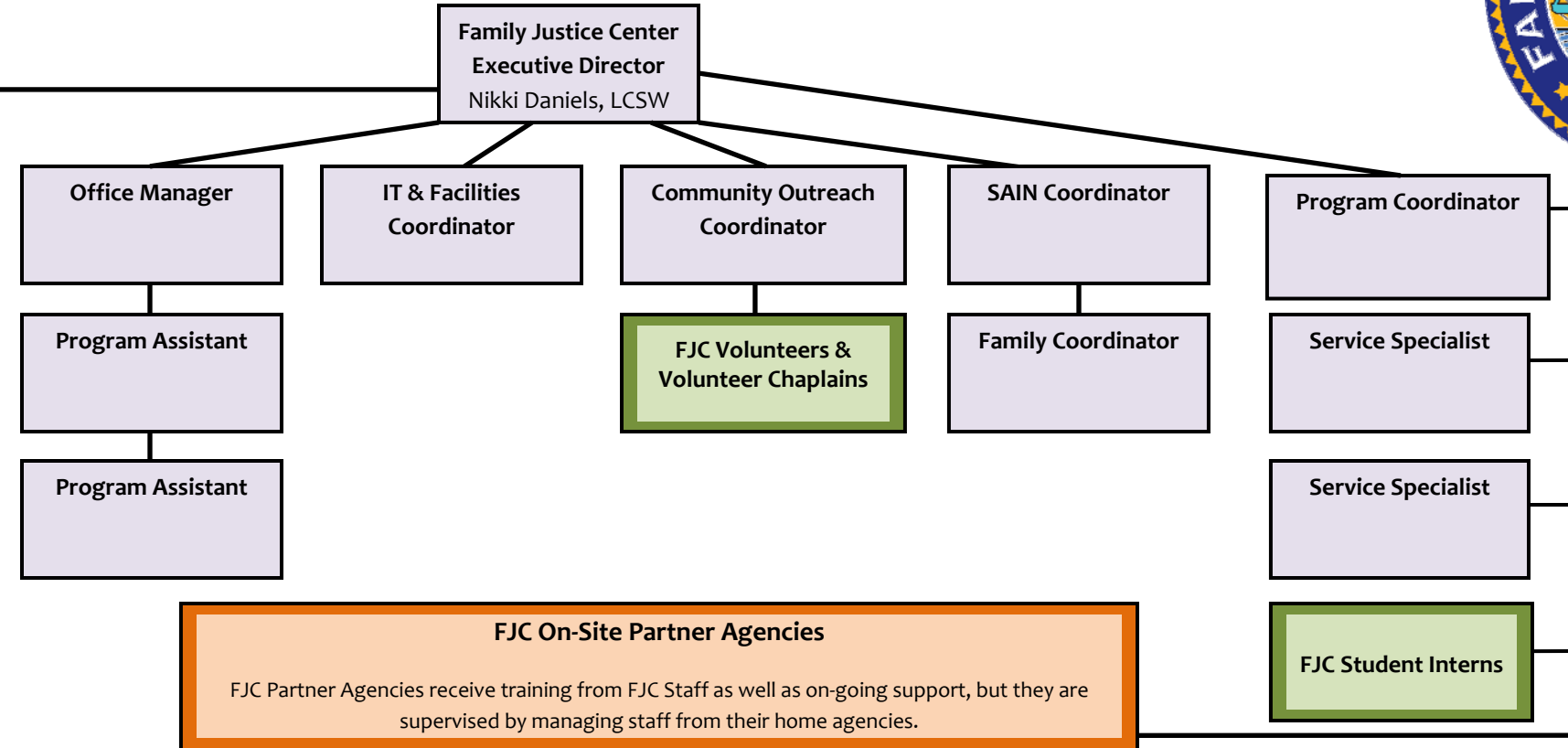


Family Justice Center of Hillsborough County, Inc. Scope of Services Organizational Chart
